Concrete hardware/picnic tables mount charges from Covid Funds - Grant was for \$4,000 for tables, concrete and a grill. Cost went over \$243.00 (?). \$150 was hardware to brace down tables. Motion made by David and Second by Corinne to cover cost of \$150.00 using Covid Fund. Balance of Covid to be used for Cemetery Survey. All agreed – Shelby B., David L., Corinne N., Stuart O.

New Business:

Proposed School Section Lake Public Access Ordinance – A draft of the ordinance was provided. Board will review and discuss further at September 3 meeting. David noted that sheriff's dept would need an ordinance in place in order to enforce the rules. Downside would be the cost of prosecution – bringing people to court.

Public comment: When would township be responsible for court cost? Only if the case is contested.

Beach picnic table site: Finish leveling – Positive comments on the new picnic tables and grill. Asked for volunteers to help fill in sand around cement pad and around old table. Meet on Saturday, 8-17-24 at 9:00 am

Primary Election Recap – Long day - 41 (In-person) + 40 (Absentee Ballots) +2 (Early Voters) = 83 voters.

Joni has learned how to test the voting machines – this will save money for the township.

Hazardous Waste Collection – August 17, 9-1:00 pm. We contributed as a township.

Unfinished Business:

MHSD Grant application for master plan – David is working on the application. Township needs a master plan.

Cemetery Survey – Surveyor indicated cemetery property is off a few feet onto Arbore Farms property and the corn field is on the cemetery property by a few feet (?) We are waiting for the completed survey.

Public Comment:

E Lake Shore Drive has a pot hole and need to trim back shoulders – still some blind spots. Who do we talk to? David will bring up the issues at the Road Commission meeting.
