New Business:

Guest Speakers: Stephanie Moore and Gwyn Adams - Oceana Council of Aging – They provided information on what Oceana Council of Aging offers: Adult Day Services, Door to Door Transportation – volunteers are needed, Meals delivered, various activities for the residents, Mobility and accessibility clinic - MUCH MORE
Renewal of Millage will be on August 6, 2024 election ballot

Township Master Plan – A five-year plan; a direction for housing and land. David will look into.

Power Loading at School Section Lake Boat Launch – Boat Launch is the Road Commission’s responsibility. David will look into this matter with our Attorneys to see what can be done (ordinance, signage)

Crystal Landing Alley (Lakeshore Drive) – 20 feet - no one has own the property since 1928. Road Commission may have control of this issue (?)

Michigan Class for Township Funds – Look into MI Class regarding funds from sale of Fire Trucks and Ruth Drive Assessments - Michigan Class may bring a higher return. It will be checked into.

Poverty Exemption – Barbie provided how one would be qualified: primary resident, low income; you would receive 100% exemption from taxes. Motion by Shelby B. and seconded by Brad N. to approve Resolution 2024-2. Resolution carries: Vote role/voice carried. Yes – 4, No – 0 Corinne N., David L., Shelby B., Brad N.

Unfinished Business:

Sidewalk at Hall – Need to reroute sidewalk. Purchase 2 more covers and additional labor. Reminded that Covid funds are being used for this project. Motion made by David L. and second by Shelby B. All approved: Brad Norton, Shelby Branch, David Leonard and Corinne Norton.

Beach – Picnic Tables – Look into additional quotes on cost of cement and labor. ADA Compliant – cement under tables and path coming from parking lot to tables.

Cemetery Survey - Part of cemetery on Arbore Farms property and 20 ft. of corn field on Colfax Cemetery. Waiting for a legal description. Need to fill out Land Division Application. David will follow up on progress.

Comment on Alley Way – noted it was public use. Plot map needs to be amended – Road Commission’s responsible.
