Contract

Minutes of a SPECIAL meeting of the Township Board of the Township of Colfax, Oceana County, Michigan, held in the Township Hall, WALKERVILLE, Michigan 49459, on August, 2001, at 7:00 p.m., OCTOBER 30 local time.

The following resolution was offered by Member SANDRA KIRWIN and supported by Member SHARON KNOWLES:

WHEREAS, the Township Board, recognizes a need for continued cooperation between neighboring communities to provide fire and rescue services, and to be able to purchase fire and rescue equipment; and,

WHEREAS, the Township Board has approved and adopted an agreement entitled "Agreement to Create the Joint Walkerville Area Fire and Rescue Authority" (the "Agreement"); and

WHEREAS, the Agreement authorizes the Joint Walkerville Area Fire and Rescue Authority (the "Authority") to borrow money and purchase equipment for the Authority, and the Township desires to participate in the purchase of a pumper-tanker fire truck; and

WHEREAS, the Township has been presented with a contract entitled the Fire Truck Acquisition and Financing Contract (the "Contract") by which the Township approves of the purchase, by the Authority, of a fire truck and the Township pledges its limited tax, full faith and credit to the payment of the Township's share of the cost thereof.

NOW, THEREFORE, BE IT HEREBY RESOLVED AS FOLLOWS:

1. The Fire Truck Acquisition and Financing Contract (the "Contract") presented to the Township Board, is hereby approved and adopted, and the Township Supervisor is hereby authorized and directed to execute the Contract for and on behalf of the Township.
2. As provided in the Contract, the Township, hereby pledges its limited tax, full faith and credit contractual general obligation for the prompt payment of its obligation to the Authority for purchase of the pumper-tanker fire truck.

3. That all resolutions or parts of resolutions in conflict herewith shall be and the same are hereby rescinded.
