RESOLUTION NO. 2020-2

RESOLUTION FOR NO WAKE SPEED LIMIT ON SCHOOL SECTION LAKE

**WHEREAS**, it is in the best interest of the citizens of the township and the property owners on School Section Lake that we take up and post, with signage a boating speed limit of no-wake on School Section Lake.

**WHEREAS**, the purpose of this Resolution is to protect the property of the residents and the township during this abnormal high-water situation.

1. The Township would limit the speed of boats on the lake to no-wake for a period of six months.
2. The starting date would follow immediately upon the approval of the Department of Natural Resources (DNR).
3. The Township would post signage at the boat ramp.
4. The Resolution (law) would be enforced by the OCEANA COUNTY SHERIFF DEPARTMENT.
  - A. COLFAX TOWNSHIP would not and does not have the means to patrol the lake.
  - B. All fines would be issued and collected by the OCEANA COUNTY SHERIFF DEPARTMENT.

### SCHOOLS OF CHOICE

Pursuant to the terms of Section 105 and 105c of the State School Aid Act of 1979, as amended by Public Act 300 of 1996 (SB 851) and Public Act 297 of 2000 which amends the State of Michigan "Schools of Choice" plan to permit school districts to accept schools of choice enrollment applications from students in contiguous ISDs, regardless of district contiguity, has been adopted by the following districts within the West Shore Educational Service District:

Baldwin Community School District  
Hart Public School District  
Ludington Area School District  
Mason County Central School District  
Mason County Eastern School District  
Pentwater Public School District  
Shelby Public School District  
Walkerville Public School District

On the following chart an X indicates the grade levels where a district can accept non-resident students and an O indicates where a district is unable to accept non-resident students. N/A indicates the program is not available. In the event requests exceed the number of openings, students will be selected by a lottery drawing. Any student wishing to attend another school district must make application to that district by the date listed for that district.

Students who are presently enrolled in the "Schools of Choice" program need not re-apply, but must indicate on the form supplied by the district they are attending that they are interested in continuing to attend that school district under the "Schools-of-Choice" plan and update any enrollment information that may be requested. Failure to return this information by the date specified by the district could jeopardize a student's continued acceptance.

Interested persons should contact the superintendent's office in the district they wish to attend for further information or an application. **Applications must be received by each district by the date listed below to be included in a lottery drawing (if applicable), and in all cases applications must be received on or before Friday, September 11, 2020.** Anyone desiring further information should contact their local school district superintendent.

## SCHOOL SECTION LAKE COLFAX TOWNSHIP

TWC-64-20-001-Temporary Slow-No Wake on the waters of School Section Lake section 15 and 16, Colfax township, Oceana county, it is unlawful for the operator of a vessel to exceed a slow-no wake speed.

"Slow-no wake speed" means a very slow speed whereby the wake or wash created by the vessel would be minimal. This temporary local watercraft control (TWC) shall supersede all other current watercraft controls and administrative rules pertaining to watercraft operations on the above-named waterbodies. The TWC shall expire six months from the effective date of this control. The boundaries of the area described above shall be marked with signs and/or with buoys at all points of public entry. It is the responsibility of Colfax township to provide, place and maintain all signage, including any buoys, to notify boaters of this TWC. This includes all public access sites within the area described above. All buoys must be placed as provided in permit issued by the Department of Natural Resources and be in conformance with Michigan approved Uniform Waterway Marking System. Buoys shall not be placed in a commercial shipping channel. This TWC is only enforceable when properly marked.

**A special meeting of the Colfax Township Board**

Was called to order for the purpose of adopting a resolution to put a temporary no wake limit on school section lake. Because of the high water encountered this year, it has been deemed necessary to slow down the lake traffic to minimize the damage to the lake as well as the low lying houses that are at least partially surrounded by water.

Various associations were represented at this meeting as well as some residents including:

The vast majority of those present were in favor of a temporary 6 month no wake, but were concerned that it not become a permanent thing and if water recedes before the 6 months are up would like to cancel the no wake order early. All were looking for a more long term option. IE: putting in some kind of lake level control or getting low lying landowners to get prepared for the occasional high water with sea walls or raising the level of their homes.

The Oceana County Sheriffs Dept. will be enforcing the order and collecting the fines for violations.
