RESOLUTION NO. 19

(SPECIAL ASSESSMENT DISTRICT 2022-1)

WHEREAS, by resolution adopted on Tuesday, April 26, 2022, at 7:00 o'clock p.m., Eastern Time, the Township Board of the Township of Colfax, County of Oceana, State of Michigan (the "Township") determined to undertake certain public improvements described in Exhibit A hereto, and assess the cost thereof to the property benefited by said improvements as described in Exhibit B, all in accordance with Act 188, Public Acts of Michigan, 1954, as amended; and

WHEREAS, the Supervisor has prepared and reported to the Township Board a special assessment roll assessing the cost of said improvements to the property benefited thereby, with the Supervisor's certificate attached thereto.

NOW, THEREFORE, BE IT RESOLVED THAT:

1. Said special assessment roll shall be filed with the office of the Township Clerk and shall be available for public examination during regular working hours on regular working days.

2. The Township Board shall meet at 7:00 o'clock p.m., Eastern Time on Tuesday, May 24, 2022, at the Township Hall located at 5594 N. 192nd Ave., Walkerville, Michigan in the Township to review said special assessment roll and hear any objection thereto.

3. The Township Clerk shall cause notice of such hearing and the filing of the assessment roll to be published twice in the *Oceana's Herald-Journal*, a newspaper of general circulation in the Township, prior to the date of the hearing, which first such publication shall be at least ten (10) days before the hearing, and shall cause notice of such hearing to be mailed by first class mail to all record owners of or persons in interest in property in the special assessment district, as shown on the last township tax assessment record of the Township, at least ten (10) full days before the date of said hearing. Said notice as published and mailed shall be in substantially the following form:

4. All resolutions and parts of resolutions insofar as they conflict with the provisions of this resolution are hereby rescinded.
