### **RESOLUTION NO. 2023-5**

#### **RESOLUTION CONSENTING TO INCLUSION OF COLFAX TOWNSHIP IN COUNTY BROWNFIELD AUTHORITY**

**WHEREAS**, the Brownfield Redevelopment Financing Act, being ACT 381 of the Public Acts of the State of Michigan of 1996, as amended (the “Act”), authorizes the County of Oceana (the “County”) to establish a Brownfield Redevelopment Authority; and

**WHEREAS**, the Board of County Commissioners has determined that it is in the best interest of the county to establish and provide for the operation of a Brownfield Redevelopment Authority (“Authority”) pursuant to the Act; and

**WHEREAS**, subject to changes that may hereafter be made pursuant to the Act, the Authority may exercise its power over property located within the boundaries of the County, provided the Authority does not exercise its power over property located within a city, village, or township located in the County unless such city, village, or township has adopted a resolution concurring with the inclusion of such property; and,

**WHEREAS**, the Colfax Township Board has determined that it is in the best interest of the Colfax Township Board to join the Authority to permit property located within its lawful boundaries to be included in the Brownfield Redevelopment Authority of the County of Oceana.

**NOW, THEREFORE, BE IT HEREBY RESOLVED:**

1. The Colfax Township Board hereby agrees to opt into the Authority so that all property located within its lawful boundaries shall be included under Brownfield Redevelopment Authority of the County of Oceana.
2. The Colfax Township Board shall file a copy of this resolution with the Oceana County Clerk.
3. All resolutions and parts of resolutions insofar as they conflict with provisions of this resolution are hereby rescinded.
